

COVID-19 Requirements, Assumption of the Risk, Wavier and Release

On behalf of myself and members of my household, I give permission for (“Student”) to attend the Southwest String Quartet Chamber Music Workshops in person and/or participate in any activities held at or sponsored by the Southwest String Quartet Chamber Music Workshops, including, but not limited to classes, lunch activities, social gatherings, etc. My Student and I, along with other members of my household, agree to follow the Requirements listed below. We assume the risk of my Student participating in the the Southwest String Quartet Chamber Music Workshops, including the risks associated with the COVID-19 virus. We also waive and release The Gregory School (THE GREGORY SCHOOL) and Southwest String Quartet from all liability directly or indirectly related to the the Southwest String Quartet Chamber Music Workshops.

Requirements

- My Student, members of my household and I will follow all The Gregory School facility policies, including all policies and procedures related to COVID-19 including, but not limited to, any policies regarding face coverings, maintaining social distance, etc., as may be enacted from time to time.
- I understand that symptoms of COVID-19 include, but are not limited to, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat congestion or runny nose, nausea, vomiting and diarrhea.
- I certify that my Student currently has none of the above symptoms, and that I and my Student will comply with all COVID-19 protocols and procedures adopted by The Gregory School, and the Southwest String Quartet, including not coming to The Gregory School or the Southwest String Quartet Chamber Music Workshops for a specified period of time, if they develop any of these symptoms or any other symptoms of illness, whether or not I believe the symptoms are related to COVID-19. If my Student is or becomes ill, I will immediately notify the Southwest String Quartet.

Assumption of the Risk, Waiver and Release

By signing this agreement, I acknowledge the following:

- My Student's participation in The Southwest String Quartet Chamber Music Workshops is completely voluntary.
- COVID-19 is highly contagious and exposure to or being infected with COVID-19 may result in personal injury, illness, permanent disability and/or death.
- Notwithstanding any precautions taken by The Gregory School and the Southwest String Quartet, being on the The Gregory School campus and/or participating in The Southwest String Quartet Chamber Music Workshops could increase the risk of my Student, a family member or me contracting COVID-19. The risk of being exposed to or being infected by COVID-19 may result from my own actions, omissions or negligence and/or the actions, omissions or negligence of others, including but not limited to, the Southwest String Quartet, The Gregory School employees, independent contractors and volunteers as well as other children and their families.

By signing this agreement, I agree to the following:

- I agree to explain all The Gregory School policies and procedures to my Student, including any changes to such policies and procedures that may be enacted from time to time, and to support my Student in complying with all such policies and procedures. I understand that my own and/or my Student's failure to comply with the The Gregory School policies and procedures could result in withdrawal of my Student from the Southwest String Quartet Workshops.
- If my Student exhibits symptoms of COVID-19 while on the The Gregory School campus or at the Southwest String Quartet Chamber Music Workshops, I understand they will be isolated from other students and participants, to the extent possible, and that a Southwest String Quartet representative will contact me or a designated emergency contact, and my Student must be picked up immediately.
- On behalf of my Student, my household members and myself, I assume the risk of exposure to and/or being infected with COVID-19 by my Student being on the The Gregory School campus and/or their participation in the The Southwest String Quartet Chamber Music Workshops.
- To the fullest extent permitted by law, I waive, release and discharge any and all claims, causes of action damages and rights of any kind against the Southwest String Quartet, The Gregory School, its Board of Trustees and all of their respective employees, agents, representatives and volunteers (the "Released Parties") arising from or relating in any way to any damage, injury, trauma, illness, loss or

death that may occur to my Student, me or any household members as a result of contracting the COVID-19 virus.

- I further agree not to sue the Released Parties, and to defend and indemnify the Released Parties for all claims, damages, losses, or expenses, including attorneys' fees, if a suit is filed concerning any injury, illness or death to my Student, a member of my household or me as a result of the COVID-19 virus.
